ARTICLES OF ASSOCIATION OF USA COOPERATIVE.

CHAPTER 1: Name and Activity

<u>Article 1</u>: Name: the cooperative will work with the name USA (United Students of Asturias) <u>Article 2</u>: Activity: buying, selling and trading. <u>Article 3</u>: Duration: from September 2011 to June 2012.

CHAPTER 2: Official site

<u>Article 4:</u> The official site will be at El Llugarín n^a 4 Granda. Siero. Asturias.

CHAPTER 3: Share capital

<u>Article 5:</u> The co-operative's share capital comprises all the contributions made by the members. In order to become a member, each person must contribute 3 euros. Once members have paid their fees, they will receive a document certifying they are members. The ownership of the share cannot be transferred. Paying the initial contribution is a necessary condition but not sufficient to be entitled to any reimbursement or to the distribution of any surplus.

<u>Article 6:</u> The reimbursement of the share capital will take place of the end of the course, once all the co-operative's debts have been paid. We have decided that each member of the cooperative will contribute with at least a 15% of the profit. This amount of money will be donated to an NGO called "Llevamos Magia"

CHAPTER 4: Organisation and responsabilities.

<u>Article 7:</u> Co-operative members are responsible for management tasks. Members form the General Assembly. The members present at the assembly constitute the quorum.

We establish four departments : marketing, production, accounting and human resources. Each department will choose a coordinator and the assembly will elect a general coordinator.

CHAPTER 5: Length of the activity.
